## Updated Bulletin for ALL TSA Employees – 9/25/2019

### Net Salary Payment Dates for Calendar Year 2020

The schedule below provides the number of paychecks that will be received in Calendar Year (CY) 2020. The schedule also indicates the dates of when the Direct Deposit net salary payment will post to personal bank accounts, and dates when paper paychecks will be mailed each pay period.

The official payment date is the Thursday following payroll weekend. The first business day after payroll processing weekend is the payment date for Direct Deposit and paper check net salary payments. Generally, net salary payments are processed with Monday's date. **Note:** When a Federal holiday falls on payroll Monday, these payments are processed with Tuesday's date.

There will be 26 paychecks reported on the 2020 W-2, with payment dates as listed with the following payment dates:

By regulation, financial institutions are not obligated to post funds earlier than the actual payment date. Employees should not rely on their financial institution providing an earlier "memo posting" of their net salary payment prior to the above payment date.

**Note: Some financial institutions may credit Direct Deposit funds to personal bank accounts prior to the above payment date. When this occurs, the bank will process the net salary payment as "pending" or "memo posting" transactions, with an effective date of Monday or Tuesday (if Monday is a Federal holiday). This earlier posting to personal bank accounts is a courtesy by some financial institutions, not all.**
