

The [Federal Benefits Open Season](#) runs from **Monday, November 12 – Monday, December 10, 2018**. During this period, you have the opportunity to enroll, change plans or cancel enrollment for the Federal Employees Health Benefits (FEHB) Program and the Federal Employees Dental and Vision Insurance Program (FEDVIP). You also have the opportunity to re-enroll or newly enroll in the Federal Flexible Spending Account (FSAFEDS) Program. Please review the chart below to learn more about your options during this Open Season.

<b>FSAFEDS</b>	<ul style="list-style-type: none"> <li>Enroll/Reenroll in Health Care FSA (HCFSA), Limited Expense Health Care FSA (LEX HCFSA), and Dependent Care FSA (DCFSA)</li> <li>Increase or decrease your election</li> </ul>	<p>Your election will <b>not</b> automatically continue. You must reenroll to continue your account(s) for the next benefit year.</p> <p>NOTE: A condition of being eligible to carry over up to \$500 from this plan year's HCFSA or LEX HCFSA is re-enrolling in either of these two plans in the subsequent year.</p> <p>DCFSA's are ineligible for carryover.</p>	<p>Visit <a href="http://www.fsafeds.com">www.fsafeds.com</a></p> <p>Currently the minimum annual election amount for all FSAFEDS accounts is \$100. The contribution maximum for the Health Care or Limited Expense Health Care FSAs is \$2,700 per participant. The maximum for the Dependent Care FSA is \$5,000 per family.</p> <p>The potential contribution maximums for Flexible Spending Accounts are determined by the Internal Revenue Service and are subject to change.
